

Resolution authorizing contract extensions for Temporary Personnel Services

(Purchasing) Estimated Annual Amount \$2,052,500.00

WHEREAS, Abacus Corporation, Proteam Solutions, Inc., Resource Staffing, Inc. and TRC Staffing Services were originally awarded contracts for Temporary Personnel Services on September 6, 2011 under Resolution Number 0642-11 (ITB# 2011-02-15).

WHEREAS, the awarded contracts were for a one year period with the option to extend for two additional one-year periods with this being the second and final one-year extension period.

WHEREAS, Abacus Corporation, Resource Staffing, Inc. and TRC Staffing Services agree to extend their current contracts for a one-year period under the same terms, conditions and pricing as originally bid, Proteam Solutions, Inc. has requested price increases.
