

Resolution authorizing the continuation of the disposal of Franklin County surplus personal property by internet auction

(FRANKLIN COUNTY PURCHASING)

WHEREAS, Section 307.12 of the Ohio Revised Code authorizes counties to dispose of unneeded, obsolete or unfit personal property by Internet Auction; and

WHEREAS, House Bill 509 deleted from Section 307.12 of the Ohio Revised Code the requirement that the Board of Commissioners to approve, on an annual basis, the continued use of internet auctioning of unneeded, obsolete or unfit personal property, including motor vehicles but still requires the Board of Commissioners to adopt a resolution expressing their intent to sell property by internet auction; and

WHEREAS, the Board of Commissioners desires to continue disposing of unneeded, obsolete or unfit personal property by internet auction and desires to provide assistance to Franklin County cities, townships and villages in the disposal of their surplus property at no cost; and

WHEREAS, the Board of County Commissioners authorizes the Purchasing Department to assist any city, township or village located within Franklin County in disposing of their unneeded, obsolete or unfit personal property through the Franklin County **GovDeals Incorporated** online internet auction site; and

WHEREAS, the Board of County Commissioners authorizes **GovDeals Incorporated** to accept the auction proceeds through bidder credit card use.

THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS,
FRANKLIN COUNTY, OHIO:

That the continuation of the use of **GovDeals Incorporated** for the disposal of unneeded, obsolete or unfit personal property by Internet Auction, to accept auction proceeds through bidder credit card use and that the Purchasing Department is authorized to assist any city, township or village located within Franklin County in selling their unneeded, obsolete or unfit personal property by internet auction is hereby approved.
